SECOND THRU FIFTH YEARS Amana will provide a free replacement part, f.o.b. Amana, Iowa for any cabinet which proves defective to rust.

SIXTH THRU TENTH YEARS Amana will provide a free replacement transmission assembly, f.o.b. Amana, Iowa for any defective transmission assembly.

SECOND THRU TWENTIETH YEARS Amana will provide a free replacement part, f.o.b. Amana, Iowa for any defective stainless steel tub.

WARRANTY LIMITATIONS:

- · Warranty begins at date of original purchase.
- Applies only to product used within the United States or in Canada if product is approved by Canadian Standards Association when shipped from factory.
- Products used on a commercial, rental, or leased basis are not covered by this warranty.
- Service must be performed by an authorized Amana servicer.

WARRANTY IS VOID IF:

- · Serial plate is defaced.
- Product has defect or damage due to product alteration, connection to an improper electrical supply, shipping and handling, accident, fire, floods, lightning or other conditions beyond the control of Amana.
- · Product is improperly installed or applied.

OWNER'S RESPONSIBILITIES:

- Provide proof of purchase (sales receipt).
- · Normal care and maintenance.
- · Having the product reasonably accessible for service.
- Pay for service calls related to product installation or usage instructions.
- Pay for premium service costs, over normal service charges, if servicer is requested to perform service outside servicer's normal business hours.
